The EU Directive (Directive 2014/26/EU) on collective management of copyright and related rights is expected to be implemented into Dutch law this year. The Directive requires the member states of the EU to report to the EU Commission (art.39) about a list of the collective management organisations (CMO's) established in their territories. In the Netherlands the College van Toezicht Auteurs- en naburige rechten (CvTA) is responsible to inform the EU Commission.

On the basis of the information at our disposal we recognise the following collective management organisations in The Netherlands:
